2. *No inappropriate behavior on the dance floor or anywhere on the grounds of the Natural History Museum as laid out in the Temecula Valley High School Dance Contract*
3. **All students and guests must have a valid picture ID to enter the prom and must be under 21-years old!!! (NO ONE WILL BE ADMITTED WITHOUT A CURRENT VALID PICTURE ID. Seriously, you have to bring it.)**
4. *Students must arrive by 9:30pm and may NOT depart until 10:00pm.*
5. *Students are responsible for the behavior of their guests and both will be escorted out of the dance without a refund if any infraction of the school rules occurs.*
6. *The administration reserves the right to refuse admittance to inappropriately dressed students or guests who do not meet the dress code laid out on the Temecula Valley High School Dress Code.*
7. *Refunds will NOT be issued if admission is denied for any reason or if requested after May 1, 2020.*

**NOTE:** Only TVHS students in the 11<sup>th</sup> or 12<sup>th</sup> grade may purchase tickets (9<sup>th</sup> & 10<sup>th</sup> grade students may attend as a guest).

***I have read and understand the above stated rules. I understand that I am responsible for my actions and that of my guest (if I have one) at all times and the TVHS Student Handbook will dictate the consequences for any infractions. In addition, I may be restricted from future TVHS activities, including graduation.***
