**6. ACCIDENTAL RELEASE MEASURES**

**ACTION TO TAKE FOR SPILLS/LEAKS:** Clean up spills immediately observing the precautions in Section 8 of this SDS. Isolate the hazard area and keep unnecessary and unprotected personnel from entering. Do not walk through spilled material and avoid breathing vapors and skin contact. Do not allow material to enter streams, sewers or other waterways or to contact vegetation.

For large spills, material should be recovered. For small spills, absorb with absorbent granules, spill control pads or other absorbent material (e.g. sand, sawdust, earth, Fuller's earth, etc.). Carefully sweep up absorbed spilled material and place in a properly labeled and covered container for disposal. Carcinogenicity** In oncogenicity studies in rats and mice, imidacloprid was not considered carcinogenic in either species.

**Developmental Toxicity** imidacloprid was not a primary reproductive toxicant. Offspring exhibited reduced body weights at the high dose and in conjunction with maternal toxicity.

**DEVELOPMENTAL TOXICITY:** In developmental toxicity studies in rats and rabbits, there was no evidence of an embryotoxic or teratogenic potential for imidacloprid. In both species, developmental effects were observed only at high doses and in conjunction with maternal toxicity.

**Neurotoxicity** Neurotoxicity studies in rats showed slight behavioral and activity changes only at the highest dose tested. There were no correlating morphological changes observed in the neural tissues.

**Mutagenicity** The imidacloprid mutagenicity studies, taken collectively, demonstrate that the active ingredient is not genotoxic or mutagenic.

**12. ECOLOGICAL INFORMATION**

**ENVIRONMENTAL HAZARDS:** This product is highly toxic to aquatic invertebrates. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters.

This product is highly toxic to bees exposed to direct treatment or residues on blooming plants or weeds. Do not apply this product or allow it to drift to blooming plants or weeds if bees are foraging in the treatment area.

Hydrolysis half-life of Imidacloprid is greater than 30 days at pH 7 and 25°C. The aqueous photolysis half-life is less than 3 hours. The soil surface photolysis of Imidacloprid has a half-life of 39 days, and in soil, the half-life ranged from 26 to 229 days.
